The Entreprise Nationale de Transport Maritime de Voyageurs (ENTMV) is launching an open national and international invitation to tender with minimum capacity requirement for:

“THE PRESELECTION OF SHIP REPAIR YARDS”

The present invitation to tender concerns qualified companies specialized in ship repairs located in the Mediterranean basin (maximum 5 days of navigation) and ports in Portugal and Spain on the Atlantic side.

The purpose of this tender is to identify the means and capacities of ship repair yards which will be later invited to bid for the maintenance operations of ENTMV car-ferries if they are selected at the end of the procedure.
